STANDARDS FOR STAFF

1. All staff who are in leadership or supervisory roles must be members (either covenant or professing) of an evangelical church.
2. Activities Directors and Kitchen Staff must understand and perform their duties as listed in the FCBC Director's Manual. Other staff must understand and perform their duties as explained to them by their supervising staff, or by the conference director or dean.
3. In addition to their particular duties during the conference, all staff members must:
 - Attend all evening services and at least one morning class (unless excused by the conference director or dean).
 - Avoid causing any distractions during any of the meeting or activities of the conference.
 - Abide by the "Rules for Delegates". The only exceptions to this are those instances where the performance of the duties of their position would preclude attendance at or participation in some particular event, and even in these instances, exceptions must be granted by the conference director or dean, or (in the case of kitchen help) by the kitchen director.
4. Staff members **may not** serve at a conference at which they are eligible to attend as delegates.
5. Staff members are expected to be a delegate at an appropriate youth conference when eligible.

RULES FOR DELEGATES

1. Christian standards of conduct are expected at all times throughout the conference. This includes respect for authority, courtesy for others, and care for the property.
2. Delegates must obey the park rules.
 - No drugs, alcohol, or firearms are permitted on the conference grounds. (Prescription drugs must be registered with the nurse, and taken only with his/her knowledge.)
 - Care for and protect plant and animal life, grounds, and park property. This includes maintaining the cleanliness of the buildings and the grounds.
3. Delegates must obey the conference rules.
 - No smoking during the conference.
 - Remain on the conference grounds unless part of a scheduled activity, or with specific permission by the conference director. Hiking may only be done with a counselor or a staff member, and with the director's permission.
 - No delegates may visit any unit other than his/her own. There is to be no raiding of cabins, even within one's own unit.
 - Taps means lights out and quiet. Remain in your cabin until reveille.
4. Delegates must contribute to the purpose of the conference.
 - Clothing must reflect Christian standards of decency and modesty, and should be appropriate for a Bible conference within a group camping environment. Clothing which inherently may be considered revealing, immodest or inappropriate, or which is worn in an inappropriate or revealing manner, will not be permitted.
 - No radios or TVs, tape, CD or digital music players, magazines or games are permitted.
 - Couples will refrain from inappropriate public displays of affection, and will remain with the group at all times.
 - Skits and songs must be appropriate to a Bible conference.
 - Sunday must be observed as a Sabbath to the Lord.
5. Delegates must contribute to the smooth operations of the conference.
 - Keep in touch with your counselor at all times.
 - Follow the schedule. Be on time for and attend all activities unless excused by the nurse, conference director or dean. (Counselors do not have authority to excuse delegates.)
 - Assist in duties (such as table setting, grounds cleaning, etc.) as requested.
